This is the 2022 Annual Monitoring Report for Green Township, Sussex County, New Jersey. In 2016, Green Township adopted a revised Housing Element and Fair Share Plan, which provided a framework for the Township to achieve its fair share of present and prospective regional need for low- and moderate-income housing. In September of 2016, the Township and Fair Share Housing Center agreed to a settlement of Mount Laurel litigation. In the Plan, the Township addressed its third-round obligations until 2025 through a durational adjustment, accessory apartments, supportive housing and other mechanisms.

Affordable Housing Activity from August 1, 2021 through April 25, 2022:

- Resolution 2021-128: Authorizing discharge of housing rehabilitation mortgage for 27 Mackerley Road in the amount of \$10,115.00 plus interest.
- Green Township Committee September 8, 2021: Discussion on Housing Rehabilitation Loans. Mr. Zschack stated that two residents have inquired about the existence of this program and requested the Committee's thoughts on continuing this program. The current Annual Income Amounts need to be adjusted and the Ioan amount per dwelling should be increased. Mrs. Padula explained the Ioan process and the money that remains in trust account. Mr. Zschack will contact the Township Planner/Administrative Agent and will discuss further with the Township Committee once the Housing Rehabilitation Program has been updated. The Committee agreed to update program documents and income limits.
- Green Township Committee December 6, 2021: The Township Clerk received the draft documents from Jessica Caldwell concerning the restarting of the Housing Rehabilitation Program.
- Green Township Committee February 7, 2022: Discussion on Housing Rehabilitation Program. The Committee reviewed the Housing Rehabilitation Program prepared by the Township Planner. Minor modifications were made.
- Green Township Committee February 23, 2022: Discussion on Housing Rehabilitation Program. The Township received and distributed via email the amended Housing Rehabilitation Program Manual.

• Resolution 2022-68: Adoption of the Operating Manual for the Administration of Rehabilitation Units, dated February 2022 and drafted by Jessica Caldwell of the firm J. Caldwell & Associates, LLC.
