Dog License 2022

All dogs 7 months of age and older must be licensed and all licenses are to be renewed by January 31, 2022.

IF LICENSES ARE NOT RENEWED ON TIME,

A LATE FEE OF \$5.00 PER MONTH WILL

BE IMPOSED AFTER FEBRUARY 10TH.

Per State Law, a license cannot be issued if the current rabies vaccination expires before November 1, 2022. If you do not renew the license, a court complaint/summons will be issued. BAG UP NJ On November 4, 2020, Governor Phil Murphy and the New Jersey Legislature enacted the most progressive bag ban law in the

country. The law reduces litter and encourages the use of reusable bags by phasing out single-use carryout bags. The law bans single-use plastic bags, regardless of thickness, at grocery stores and retail establishments, as well as paper bags at grocery stores at or larger than 2,500 square feet. It also bans polystyrene foam takeout containers and other products such as plates, cups, food trays and utensils. As of November 4, 2021, plastic straws will only be available upon request. The "Bag Up NJ" campaign is the New Jersey Clean Communities Council's new single use plastic and paper bag ban outreach campaign, which has a simple message: Bring your own reusable bags when you shop. This new law will officially go into effect on May 4, 2022, in New Jersey. All stores (including retail), food service businesses, and grocery stores are prohibited from selling to, or providing

customers with, single-use plastic carryout bags.

Questions about wild animals or dog licenses??

Who do I call if I have found a lost dog or cat? Please call the Animal Control Officer, Alan DeCarolis, at 908-377-0808.

What do I do if I have lost my dog or cat? Please call Alan DeCarolis at 908-377-0808. You may also call Town Hall to see if anyone has reported finding a lost dog or cat.

What do I do if I have a dead animal on the road in front of my house? Please call Town Hall at 908-852-9333 if you live on a Township Road. If you live on a County Road you can call the county at 973-579-0430 x1.

What do I do if I have a dead animal on my property? If you find a dead animal, such as a deer, on your property you can either drag it to the road and call Town Hall or the County (depending on which road you live on) OR you can call the Lakota Wolf Preserve at 908-496-9244 or Space Farms at 973-875-3223. There may be a fee for pick up.

What do I do if I see deer on my property? Nothing. This is the country and they are part of the rural, country area. You may want to research deer resistant plants if you have not done so already.

What do I do if I see a bear on my property? Although bears look cute and cuddly, they are not. Do not approach the bear. Usually, if you leave it alone it will leave you alone. You should NEVER feed bears from your property as this will keep them coming back and will eventually cause problems.

When do I have to get a Dog License? All dogs over 7 months must be registered with the town by January 31 each year. A late fee applies after February 10th. This annual license can be renewed online for existing dog licenses (providing the rabies certificate does not expire by November 1st) but all new registrations must be done in person at Town Hall.

Where can I get the registration form for a new dog/puppy? This form is located on the Green Township website, www.greentwp.com under Animal Control.

What if my dog's rabies shot is expired? You will need to take your dog for another rabies vaccination. The vaccination cannot expire before November 1 of the year you are renewing.

I heard there was a rabies clinic in town? Green Township holds a FREE rabies clinic the first Saturday in November each year.

I got a "2nd notice" in the mail, what does this mean? Sheri, the Dog Licensing Official, will send this to you as a reminder you need to renew your dog's license.

What is the late fee? The late fee is \$5.00 per month, per dog after February 10th.

What could happen if I do not renew my dog's license? If you do not renew the license a court complaint/summons will be issued by the Animal Control Officer.

What do I do if my dog passed away and I no longer need to renew the license? Please call Town Hall to let

Sheri know so she can take your dog out of the system.

Do I need to license my cat? No, Green Township does not require a cat license.

Who do I call if I have questions? Please call Sheri at 908-852-9333 x10.

Important information regarding fire hydrants and snow removal

Ordinance 17-2.7.1 Removal of Snow Around Fire Hydrants -

The owner, owners or lessees of any real property in the Township abutting any fire hydrant shall maintain the area within a five-foot radius of the perimeter of any such fire

hydrant free of snow. The removal of snow shall be completed within 24 hours of daylight after the snow has formed or fallen or accumulated on or around any fire hydrant. On failure to perform the required clearance within the specified time frame, the Township, or any department thereof, may perform the clearance and bill the responsible party no more than \$75.

There is **NO PARKING** on any road during snow storms, cars will be towed at owner's expense. There will be **NO** plowing, shoveling, or snow blowing of snow into the roads. Please make sure all sidewalks on your property are cleared of snow within 24 hours of storm.
