### DOG LICENSE 2024

All dogs 7 months of age and older must be licensed and all licenses are to be renewed by January 31, 2024. IF LICENSES ARE NOT RENEWED ON TIME A LATE FEE OF \$5.00 PER DOG PER MONTH WILL BE IMPOSED AFTER FEBRUARY 10TH.

Per State Law, a license cannot be issued if the current rabies vaccination expires before November 1, 2024. If you do not renew the license, a court complaint/summons will be issued. # CELEBRATING THE BICENTENNIAL - 1824 - 2024

## A LITTLE HISTORY...



### ONCE UPON A TIME THERE WAS A LAKE IN THE VILLAGE OF BRIGHTON.

Actually, it was called Brighton Pond.

It was created as a millpond behind an earthen dam that is 160 feet long, 15 feet wide, and 8 to 10 feet high. The dam is still there, it has been breached but is still intact otherwise, and the Pequest River still runs through the mill race that has walls on either side that were built with large local limestone blocks. The water running through the millrace originally provided power for the Huntsville log sawmill, gristmill, and forge built by Thomas Wolverton.

Thomas Wolverton came from Hunterdon County in 1750 and purchased land from Samuel Green. He selected 91 acres at the location on the Pequest River where the land is high enough on both sides of the river to provide a suitable location for the dam and millpond. After a few years, Thomas Wolverton sold the property and after several owners, it was purchased by Joseph Gaston who built the four-story gristmill, (shown in the photos). This mill operated throughout the nineteenth century with water power supplied from Brighton Lake.



Bill Morris (who lived his entire life on this property) and his father Harvey removed the top two stories of the 4 story grist mill in 1925. Bill was thirteen years old at the time and he accidentally cut off the first digit of his left index finger with an axe. He told me several times that his mother kept that finger in a bottle of alcohol for a time.

The mill was completely demolished about 1942. The large stone grinding wheel was buried on the property and a school bus garage was built on the site.

Brighton Lake was fed by two sources. The first, Pequest Creek drains from Whittingham Wildlife Area, Muckshaw Ponds preserve, and Stickle Pond; and the other, Kymer Brook drains from Lakes Lenape, Aeroflex, Iliff, and Gardeners Pond, White Pond, and Twin Lakes. These two tributary streams come together to form the Pequest River at the upstream end of Brighton Lake.

It was because of Brighton Lake and the waterpower it provided that Huntsville was once a leading industrial, cultural, and shopping center for this area.

Huntsville at one time had a gristmill, a sawmill, a wheelwright shop, an icehouse, a limekiln, two blacksmith shops, a post office, a school, and six stores, two being the best general stores in the county. Most of these buildings are gone and the village would be unrecognizable to earlier residents.

The lake could not have been seen from Huntsville. A great view would have been from the high ground at the location of the home that is now Crossed Keys, with Turtle Pond on one side of the road and the lake on the other. At that time there were few trees to block the scene.

It would have been seen from the present-day Cahill farmhouse and also looking downstream from the Brighton Creamery building around the corner from Cahill's on Brighton Road and Kymer Brook, now a residence.

Brighton Lake today has returned to its natural state; wetlands, and woodland.

It probably looks now much as it did when the first settlers came to Green Township.

The only thing missing are the Indian campsites that were located on the banks of the rivers in this area.

The Township of Green operates under the Township form of government. This is the oldest form of municipal government in New Jersey, having been first established by the Township Act of 1798. The township form of government is "government by committee" with the legislative and executive responsibilities of the municipality vested in the township committee as a whole.

The Committee establishes policies for the administration of the various departments and appoints the Township Administrator who is responsible for carrying out those policies and overseeing the day to day operations of the township.

The Township Committee members are elected officials whose three year terms of office begin on January 1 following their election at the November General Election. At the reorganization meeting during the first week of January, the Township Committee elects one of their members to be the Mayor and another to be the Deputy Mayor.

## A MESSAGE FROM THE TAX COLLECTOR

If you are paying online, the only search information you need to type in is the name of your road. The list will populate all house numbers, and you can choose from that list. All last names were removed due to Daniel's Law. It isn't necessary to set up an account to complete your online payment.

**Please refrain from post dating your checks. We are not allowed to hold them in the office, all checks must be deposited within 48 hours. Post-dated checks will be returned.**

If you are paying cash for your taxes please come in on a Monday, Wednesday or Thursday so Karen can help you.



## TAX COLLECTORS CORNER:

Here is a review of available deductions and programs to be sure you're taking advantage of all you can:

### Municipal Property Tax Deductions

**Senior Citizen/Disabled/Surviving Spouse:** If you were 65 years or older as of December 31st of the previous year, you may be eligible for a deduction of \$250.00 annually from your gross property tax amount. There is an income limitation of \$10,000.00, combined if married, excluding social security. Complete eligibility requirements are listed on the application form.

Applications are available in the Tax Collector department at [www.greentwp.com](http://www.greentwp.com).

**Veterans:** If you have served in the armed forces, or if you are a widow of a veteran that never remarried, you may be eligible for a deduction of \$250.00 annually from your gross property tax amount. There is also a 100% permanently disabled veteran deduction which grants full tax exemptions for qualified veterans. Complete eligibility requirements are listed on the application forms. Applications are available in the Tax Collector department at [www.greentwp.com](http://www.greentwp.com).

### State of New Jersey Property Tax Relief Programs:

**Senior Freeze (Property Tax Reimbursement Program/PTR):** Provides direct property tax relief, in the form of a refund check, to homeowners who meet the eligibility requirements. For more information and an application please call (800) 882-6597 or online.

**ANCHOR Program:** This program provides property tax relief to New Jersey residents who own or rent property in New Jersey as their principal residence and meet certain income limits. For more information and an application please call (888) 238-1233.

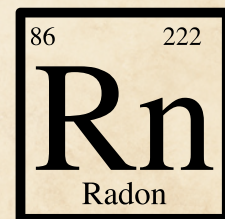

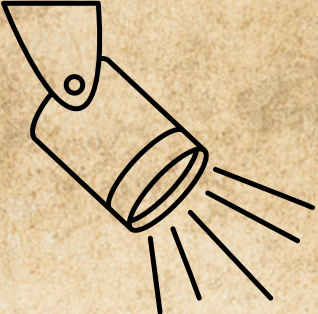


Every Saturday

#### Low Income Home Energy Assistance Program (LIHEAP)

**Online Applications Now Available.** Customers with a household income at or below specific income limits can apply. Utility heating customers typically receive an average of \$300 toward their electric or gas bill.

#### LIHEAP Emergency

Recipients of the federal Low-Income Home Energy Program may be eligible to receive an additional grant of up to \$1000.00 in LIHEAP Emergency funding. To be eligible, you must be a LIHEAP recipient and have a past due balance of \$300 or greater. You may apply for a LIHEAP Emergency Grant at your local agency from March 16 through June 30 each year.

#### Universal Service Fund (USF)

If you apply for LIHEAP, you are also applying for USF. Electric or gas utility customers can receive from \$5 to \$180 per month toward their utility bills. USF accepts applications year round.

#### USF Fresh Start (Erase your past due balance!)

USF customers are automatically enrolled in the USF Fresh Start program if their natural gas bill is in arrears of more than \$60. Participants are required to pay their current bill on-time, every month, for 12 months, to have a past due balance erased. 1/12th of a participant's overdue balance will be waived each month their current bill is paid.

#### Payment Assistance for Gas and Electric (PAGE)

The PAGE grant is a financial assistance program designed to help low to moderate income families in New Jersey who are experiencing economic hardship and struggling to pay their electric and natural gas bills. If you are a NJ resident who rents or owns a home and are facing a crisis situation that includes a documented notice of overdue payment for gas and/or electric service—you may qualify.

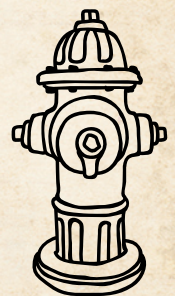

## FIRE HYDRANTS

### Ordinance 17-2.7.1 Removal of Snow Around Fire Hydrants

The owner, owners or lessees of any real property in the Township abutting any fire hydrant shall maintain the area within a five-foot radius of the perimeter of any such fire hydrant free of snow. The removal of snow shall be completed within 24 hours of daylight after the snow has formed or fallen or accumulated on or around any fire hydrant. On failure to perform the required clearance within the specified time frame, the Township, or any department thereof, may perform the clearance and bill the responsible party no more than \$75.
