# MATTERS FROM THE TOWNSHIP CLERK: Mr. Zschack noted the following matters:

**Elizabethtown Gas Installation** - The installation project is moving along with only one additional complaint that Elizabethtown Gas is looking into.

**Open Space Fund** - At the last meeting it was the consensus of the Committee to consider using Open Space funds to make improvements to EverGreen Park. We have created a potential list of improvements that will be presented once all costs associated with each project are determined.

**Farm Trinca Agreement** - The Notice for Solicitation is posted with an opening date of March 13, 2024, at 11:00 a.m. The Township is accepting quotations for farming and serving as a steward of a portion of the Township owned property located at 93 Airport Road.

MS-4 Permit Requirements - We are, when time allows, working on the mapping of all stormwater structures in the Township. To date we have approximately 50% of structures located. We are also working on the Stormwater Pollution Prevention Plan updates. We still need to adopt eight (8) separate ordinances to comply with the grant.

**Township Wide Reassessment -** On February 21<sup>st</sup>, the Tax Assessor and I attend the County Board of Taxation meeting. On their agenda was a discussion for the reassessment order to Green Township. The County Board adopted a resolution that will be sent to the NJ Division of Taxation for their approval. Once adopted by the State we can move forward with the bidding process. A draft RFP will be presented once completed.

Master Plan Grant - We received a scope of work from J Caldwell & Associates concerning the Highlands Plan Conformance Grant. This document was emailed on February 26<sup>th</sup> and to date we have received no concerns. The only change I requested was to alter the completion date to be before the year's end, this was agreeable. This scope of work will complete the grant application and will determine the exact amount of the grant. Once this is completed, we will present a resolution for a contract with J Caldwell & Associates for the Master Plan Update. (anticipated grant amount \$40,000)

**Local Recreation Improvement Grant** - All equipment for the movie screen and projection have been received. A test of this equipment is planned for this week. The \$14,950.00 cost was covered by this grant. Kudos to the Recreation Committee for their efforts in securing these monies.

**Stormwater Utility Grant** - We have a Microsoft Teams meeting every other week with Anthony Dill of Arcadis Engineering. We are providing information concerning the Townships' cost of stormwater equipment, maintenance, repairs, inspections, etc. We have also provided qualified farmland data, that promoted a Teams meeting today that included the Tax Assessor.

**Recycling Tonnage Grant** - Correspondence will be sent this week to all commercial properties concerning the submission of their recycling tonnage information. This is the second year all work will be done in-house with SCUMA signing off on the report. An additional employee will be trained in this endeavor.

**Peddler's License Application** - We received an application from Dolly Jingles Ice Cream, an ice cream truck that will drive around town selling ice cream. The Township Attorney reviewed the application. The truck is not allowed to park on municipal properties including the parks but can sell on the streets.

Qarmout asked if the driver will have a background check. The Township Attorney stated the applicant has checked off that he has not been convicted of any crime, misdemeanor, or violation of any municipal ordinance. The No Knock Registry will be supplied to the applicant. The Township Attorney explained that the Law states that we can only ask the question. The applicant needs to supply references and other municipalities the applicant has solicited in. The applicant will also supply a Food Handler's License.

**Projects** - The Township Clerk has been creating a spreadsheet of all the upcoming projects, purchases, RFPs, etc. for tracking purposes.

## MATTERS FROM THE GOVERNING BODY:

DeYoung commented on the Master Plan and the impact of warehouses and to be clear to avoid challenges in the future.

DeYoung gave kudos to the Bicentennial Committee for the events planned.

Qarmout thanked the CMFO and everyone involved with the budget as well as the Bicentennial Committee for their efforts in planning events.

Raffay also thanked everyone involved in planning the Bicentennial events. Raffay stated that a resident on Hillside Terrace thanks the Road Department and is happy that her yard looks the way it should.

Mayor Phillips explained Assemblyman Inganamort met with her and the Township Clerk. Mayor Phillips informed him of Green Township's Bicentennial celebrations and possible and asked if there could be any recognition from Trenton. Also discussed was the veteran property tax, stormwater situations, and the matter of property with residential facility and that tax exemption and concerns.

Mayor Phillips noted the communication in response to the resident's complaint regarding the Elizabethtown Gas project. A response will be provided to the resident.

No further or additional refund of taxes shall be permitted, regardless of the date of the disability of the veteran as determined by the United States Department of Veterans Affairs.
