MINUTES: Approval of Minutes of April 18, 2017. Motion to accept the minutes made by Patty seconded by Brad. No discussion. All Ayes.

BUSINESS: Chair Yoga

The Recreation committee decided it would be a great idea to offer chair yoga to the seniors and other residents of Green Township. - We need to request the delivery of the tents, tables and chairs for Friday so there is no need to put them in the pavilion and then take them back out again. Set up time will be based on what time they deliver.
- Colleen will order the sashes, tiaras, and flowers and check on the plates, cups, etc. She will pick all of that up when she gets the ½ sheet cake. Wristbands will be used to identify the paid guests.
- Keith Ramos, Debbie Danielson and Paula Schul are scheduled as judges but Sabrina Burke and/or Gigi Regolizio could be used as backups.

2. **Summer Rec:**

- Sparta Lanes is reserved for the trip, there are 2 senior counselors and 2 junior counselors as of right now. 6 kids registered.
- Brenda stated she can't have the counselors approved yet because she doesn't even know how many she needs and who they are.
- Kim will provide Brenda with a weekly mailing with all the registration forms that come in.
- Colleen will take registration flyers to the kindergarten orientation and Kim will send the Miss Green flyers to the high schools. Brenda will hand out Movie in the Park flyers to the camper the first week of camp.
- Summer Rec will be at the park each Wednesday of camp. July 12, 19, and 26.

3. **Movie in the Park:**
