The members of the Fire Department would like to explore the purchase of a mini pumper in the price range of \$375,400.00.

**MATTERS FROM THE TOWNSHIP CLERK:** Mr. Zschack noted the following matters: **OEM Council** - Due to a new position on the Region 2 US Department of Homeland Security Task Force, Pete Sklannik must resign from the OEM Council.

**Professional Rotation** - On the request of Mayor Phillips we have reviewed the current rotation list for the renewal of professional services. This indicates that the Land Use Attorney is to be evaluated for 2024 and the Auditor position in 2025.

**Planet Networks -** On Tuesday, November 28<sup>th</sup> Planet Networks will be on site from 8:30 a.m. to 12:30 p.m. upgrading our systems. Emails and phones will be intermittent during this time and office personnel will be working on the paper filing system. We are also in discussions with Planet Networks to provide additional services.

**Recreation Committee** - We have received a recommendation from the Recreation Committee to remove the current holiday tree and plant a new twelve (12) foot tree in its place. If there are no objections, DPW will be directed to plant said tree.

**Municipal Aid Grant** - Green Township has been informed that a \$174,196.00 grant was awarded for the reconstruction of Henry Road. With an estimated cost of approximately \$294,000.00, the Township's cost is about \$120,000.00. The bridge will be taken into consideration.

**Garbage Contract** - The current contract expires in March 2025. It is recommended to start the RFP process at least 18 months to 2 years ahead of time. The QPA will be contacted for a basic RFP to start the discussion on options.

Rose attended the League of Municipalities Conference last week and commented that it was very well attended.

Rose commented about possibly utilizing Open Space funds to pay for a pickle ball court to add to EverGreen Park.

Rose asked if there was a response regarding the fire coverage services. The Township Attorney responded there has been no response.

Rose asked if the Subcommittee assignments can be reviewed and diversified for 2024 to allow for more participation from the Committee members. Mayor Phillips stated that Subcommittees are appointed by the Mayor. The 2024 Mayor will review and consider suggestions for any revisions.

### MATTERS FROM THE SUPERINTENDENT OF PUBLIC WORKS: The Superintendent of Public Works provided the following report:

- Both mowers are down again hopefully having the green john deer fixed by next week.
- Trees taken down on Terhune, Hillside and Mackerley. Phase #2 will continue on 12/4/2023 or sooner depending on the weather.
- All trucks 80% plow ready, waiting for parts to be 100% ready.
- Luis completed and passed his CDL class.
- Fall clean-up of drains is on the way.

- Creek road project is 100% complete, paving, line stripping and guide rail installation.
- Fall seasonal work on the trails and parks has begun. With the ground getting harder access to the fields and trail are made easier to do cleanup of brush and trees.
- We used a demo "Hot Box" trailer by one of our venders to try out patching with hot mix in the cooler days of October. It worked out very well, we were able to lay down 20 tons of asphalt over a weeks' time. Three to four tons a load and keep the material hot and pliable. We were able to put down berm, holes, and even strip patching was done very efficiently.
- The new mason dump truck is at the Henderson shop and in line to have the plow and sander installed. The new truck is due to be delivered mid-December.

## AN ORDINANCE REVISNG GREEN TOWNSHIP CODE SECTIONS 30-34.2, 30-44.2, 30-45.2 AND 30-50.2 TO PERMIT ROOFTOP SOLAR ARRAYS ON EXISTING STRUCTURES

**WHEREAS**, Green Township Code Sections 30-34.2, 30-44.2, 30-45.2 and 30-50.2 permit rooftop solar arrays as accessory uses within the AR, R, NC, RB and AI-10 Districts; and

**WHEREAS**, the Township has received public comment regarding a desire to construct residential rooftop solar arrays in a more expedited way on existing residences without need for Land Use Board approval; and

**WHEREAS**, the Township has reviewed its Code and desires to amend the Township Code to permit roof-mounted solar systems on lawfully pre-existing structures in a more expedited way, to support renewable energy and the use of solar energy, as encouraged by New Jersey legislation.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Green, Sussex County, New Jersey, as follows:

#### **SECTION 1.**

Green Township Code Section 30-34.2(i), concerning rooftop solar arrays as permitted accessory uses in the AR Agricultural Residential Districts and R Residential Districts, shall be deleted in its entirety and replaced as follows:

i. Rooftop solar arrays constructed within the confines of and not extending beyond the footprint of lawfully pre-existing structures, which solar array height shall not exceed twelve (12") inches above the existing roof surface and resulting in an overall height in conformance with that permitted for the principal structure in the zone district in which the property is located. All rooftop solar arrays shall be setback at least five (5') from all property lines. The design of the solar array shall conform to all applicable industry standards including the New Jersey Uniform Construction Code, the National Electric Code. A building permit shall be applied for and obtained prior to construction. All design and installation work shall comply with all applicable provisions in the National Electric Code and relevant building and fire regulations.

#### **SECTION 2.**

Green Township Code Section 30-44.2(e), concerning rooftop solar arrays as permitted accessory uses in the RB Business District, shall be deleted in its entirety and replaced as follows:

e. Rooftop solar arrays constructed within the confines of and not extending beyond the footprint of lawfully pre-existing structures, which solar array height shall not exceed twelve (12") inches above the existing roof surface and resulting in an overall height in conformance with that permitted for the principal structure in the zone district in which the property is located. All rooftop solar arrays shall be setback at least five (5') from all property lines. The design of the solar array shall conform to all applicable industry standards including the New Jersey Uniform Construction Code, the National Electric Code. A building permit shall be applied for and obtained prior to construction. All design and installation work shall comply with all applicable provisions in the National Electric Code and relevant building and fire regulations.

#### **SECTION 3.**

Green Township Code Section 30-45.2(e), concerning rooftop solar arrays as permitted accessory uses in the NC Neighborhood Commercial Districts shall be deleted in its entirety and replaced as follows:

e. Rooftop solar arrays constructed within the confines of and not extending beyond the footprint of lawfully pre-existing structures, , which solar array height shall not exceed twelve (12") inches above the existing roof surface and resulting in an overall height in conformance with that permitted for the principal structure in the zone district in which the property is located. All rooftop solar arrays shall be setback at least five (5') from all property lines. The design of the solar array shall conform to all applicable industry standards including the New Jersey Uniform Construction Code, the National Electric Code. A building permit shall be applied for and obtained prior to construction. All design and installation work shall comply with all applicable provisions in the National Electric Code and relevant building and fire regulations.

#### **SECTION 4.**

Green Township Code Section 30-50.2(f), concerning rooftop solar arrays as permitted accessory uses in the AI-10 Agricultural Industrial District, shall be deleted in its entirety and replaced as follows:

f. Rooftop solar arrays constructed within the confines of and not extending beyond the footprint of lawfully pre-existing structures, which solar array height shall not exceed twelve (12") inches above the existing roof surface of a peaked roof and not exceeding a height of four (4') feet from the existing roof surface of a flat roof, and not resulting in an overall height in excess of that permitted for the principal structure in the zone district in which the property is located. All rooftop solar arrays shall be setback at least five (5') from all property lines. The design of the solar array shall conform to all

applicable industry standards including the New Jersey Uniform Construction Code, the National Electric Code. A building permit shall be applied for and obtained prior to construction. #### **SECTION 5**

If any provision of this Ordinance or the application of this Ordinance to any person or circumstances is held invalid, the remainder of this Ordinance shall not be affected and shall remain in full force and effect.

#### **SECTION 6 - REPEALER**

All ordinances or parts of ordinances or resolutions that are inconsistent or in opposition to the provisions of this Ordinance are hereby repealed in their entirety.

#### **SECTION 7: EFFECTIVE DATE**

This Ordinance shall take effect immediately upon adoption and publication in accordance with law.

#### **SECTION 8: NOTICE**

The Township Clerk is directed to give notice at least ten days prior to the hearing on the adoption of this Ordinance to the County Planning Board and to all others entitled pursuant to the provisions of N.J.S.A. 40:55D-15. Upon the adoption of this Ordinance, after public hearing, the Municipal Clerk is further directed to publish notice of the passage and to file a copy of this Ordinance, as finally adopted, with the Sussex County Planning Board, as required by N.J.S.A. 40:55D-16.
