Members present: Jim DeYoung, Peg Phillips, Gladys Golder, Patty DeClesis, and Brenda Grasso. Also present was Christine Licata, Secretary and Chris Bilik. Brad Jones and Diana Fox were excused on a motion made by P. DeClesis, second by G. Golder. Approved by all, motion passed.

NEW BUSINESS:

1. <u>Discussions</u>

a. New Business

1. January meeting date/time

• Due to the Township Committee meeting change in January, the Recreation Committee meeting has been moved to January 14th at 7:00pm from January 21st at 7:00pm.

2. Chair/Vice Chair

- Since no one has expressed an interest in being Chair for next year, J. DeYoung commented that he will be continuing on the committee and is willing to fill the chair position if no one else wants the position.
- G. Golder will let the committee know at if she would be interested in the Co-Chair position for next year.

3. Girl Scouts

- B. Grasso explained that the Girl Scouts are now under a new service unit which includes Green, Andover and Newton Townships. This has changed the outlook of the Girl Scout program. The Girl Scouts are not 100% committed to attending the tree lighting. P. Phillips spoke with Rose Matonis in regards to the Girl Scout participation. Rose will distributed the song books to the leaders, but informed P. Phillips that participation may be low.
- J. DeYoung will give a follow up call to Rose and explain that the committee would like to keep the tradition of having the Girl Scouts participation at the recreation events. J.

d. Tree Lighting

- C. Licata mentioned to the committee that W. Perigo would like to buy some new lights as some strands are not working well. The committee agreed that W. Perigo could buy whatever he needs in lighting.
- J. DeYoung contacted the Firehouse and confirmed the time of Santa arrival.
- P. DeClesis ordered the giveaway.
- J. DeYoung will not be able to attend.
- Committee will provide hot cocoa and coffee. Girl Scouts will provide cookies.

e. Gingerbread House Contest

- P. Phillips picked up the ribbons for the winning houses.
- Judges have not been set up yet.
- Houses will be brought to Town Hall Saturday afternoon. P. Phillips may need to push the time back and will coordinate with the residents who are submitting houses.

f. Ho Ho Hot Line

- Flyers were sent to the school and to Green Apple Academy.
- Patty reached out to 2 possible Santa's and is waiting on a response.
- P. DeClesis will not be able to open the building and asked if someone else could be available.
- There was suggestion for next year to have a Mrs. Clause as well as Santa.
