## **BUSINESS**:

1 and 2. Drive In Movie: Colleen briefly spoke about the idea of a Drive In Movie. Suggestions were made by Cyndy (via email to Kim) to do a double feature, showing a family movie first and then a horror movie after.

Kim read the prices she obtained from "any Excuse for a Party" rental company.

It was discussed that a fire truck could possibly be used to raise the screen instead of risers from the rental company. Kim will call Mt. Olive Recreation to discuss their drive in movie details.

There were some questions about how to safely move the cars in and out for a double feature, this will be looked at if approval is given.

The airport does not have any bathrooms so we will have to rent porta johns for the event.

We will ask the fire department for portable lighting.

It was suggested to have some type of game, possibly bingo, while the cars are waiting for the movie to start.

We will have to go to the field to see how to set everything up.

The registration should have the vehicle type listed so the larger vehicles can be placed in the back.

The rec committee would like to do this in October as a Halloween event, the weekend before Halloween was suggested. We should ask Tranquility Farms about pumpkin donations to give out at the movie.

3. Since the Gingerbread Decorating event probably will not happen due to COVID guidelines, it was suggested we set up gift bags with gingerbread houses in them to give away to families in town. They could bring them home to do as a family. A "DO NOT EAT" note should go in the bag and maybe a winter/holiday craft as well.

We would need Township Committee approval on this modified event also.

4. The Tree Lighting event was tabled for the next meeting since guidelines could change before then.
