MATTERS FROM THE GOVERNING BODY: Mr. Kurzeja spoke with Mr. Nittolo, Principal at Green Hills School to find out what security companies the school has looked into. The school called in the State Police and the Sheriff's Department to get their recommendations. They are in the process of reviewing several proposals. It was suggested that Mrs. Peralta ask the State Police to give us their recommendation.

Mr. Bilik reviewed the proposal he received for grant writing research for projects in the Bond Ordinance. The company would charge an initial fee up to \$2,000.00 to see what grants are available. There is an additional cost to do the research. After a brief discussion, the Committee would like to have the company attend a meeting. They would like to know their success rate, the historical response, what are they finding in a town our size and references from other municipalities. Mr. Bilik will arrange for them to attend an upcoming meeting.

Mr. Chirip asked if the Legislature would be able to hold meetings in the evenings. Since the Committee members work during the day it is difficult to attend these meetings during the day.

- The Township has received \$52,947.00 back from FEMA for expenses incurred during Hurricane Sandy, thanks to Mr. Jim Powderley, Mr. Perigo, Mr. Caruso, Mr. Rafferty and Mrs. Padula. Mrs. Phillips thanked those involved for their time and effort in recouping money back for the town. Mrs. Peralta is still waiting to hear from the county on the generators.
- Application from Diana Fox for membership to the Recreation Advisory Committee Mayor Conkling explained the Committee is only allowed 7 members, including 2 members of the Township Committee as liaison which they currently have. The only way to appoint would be to remove Mr. Bilik as a voting member. Mr. Bilik would still be a liaison. Mr. Bilik is fine with that. Mayor Conkling will appoint Mrs. Fox. A resolution will be done for the next meeting.
- The foreclosure process is continuing.
- The Senior Citizens have asked to have a webpage on the Green Township website. The Seniors are not affiliated with the Township therefore the Committee is not in favor of the request. There is also no one available to maintain their information for the website.
- There is \$17,000.00 available in the Dog Trust Account. The money is used to pay the salary for the Dog Licensing Official and the Animal Control Officer, the rabies clinic, and a dog census which must be conducted every two years. It has been several years since the last one was conducted in Green Township, therefore Mrs. Peralta will move forward on conducting a dog census.
