Mayor Raffay introduced the Township Engineer, Tom Knutelsky and Sean Walsh of Princeton Hydro.

Sean Walsh stated that Princeton Hydro has been contracted to conduct a drainage study for Lake Tranquility. The purpose of this meeting is to receive the public's input about existing drainage issues and gather information available for the drainage area. Sean asked the public to pin the location on the map to identify the problem. The Township Clerk assisted with this process.
