#### CALL TO ORDER

The February 25, 2013, meeting of the Green Township Committee was called to order at 6:15 p.m.

#### PLEDGE OF ALLEGIANCE

Mrs. Peralta read the statement of adequate notice.

#### DISCUSSIONS:

- a. Budget Mrs. Padula reviewed the following changes that were made since the last budget meeting:
  - Removed items such as the ambulance, salt shed at the DPW Yard, Municipal Building parking lot, DPW trucks, recreational fields and replacement of the roof at the municipal building. These items are included with the Bond Ordinance
  - In turn, kept the capital improvement fund at \$55,000.00
  - Increased debt services.
  - Increased administrative O&E budget by \$51,000.00 for security measures in the municipal building, grant writing and changes in personnel
  - Have not heard from State regarding the DOT grant funding. The budget can be amended accordingly.
  - At this time, the budget is at a municipal tax rate of zero increase

The budget will be introduced on March 11 and adopted at the April 8 meeting. Mr. Bilik asked what kind of aid we can expect in 2014 with anticipation of lost revenues from Superstorm Sandy. Mr.Ferry explained the Township's surplus account is at a comfortable level. Mr. Kurzeja asked about the municipal court budget. It was explained that at this point, the Township is not sure what direction they are in, will have a better understanding after the upcoming budget court meeting. Costs associated with the Deputy Court Administrator were kept in the budget, minus health benefits. Mr. Conkling asked Mr. Ferry for his opinion in the fact that there has been no increase in taxes for the past 4 years. Mr. Ferry believes that it is a good practice to raise taxes accordingly. Green Township has been frugal with their budgets and kept costs low and revenues higher, however there will be a time when expenditures catch up to revenues. At this time, Mr. Ferry feels there is enough in the surplus. Mr. Bilik asked the Committee to revisit the Open Space Tax. The Open Space fund is well funded therefore Mr. Bilik feels the Township can lower the tax rate from 3 cents to 1.5 cents on a 100. The Ordinance states the Township can set the rate annually therefore this tax can be adjusted each year. Mr. Bilik made a motion to change the rate from 3 to 1.5 cent for 2013

Discussion: The Committee discussed the average cost to the household at 3 cents and 1.5 cents and the long term implication of reducing this tax.

All information is available on Appraisal Systems website for any resident to review. The average was 25% loss in value. There was further discussed the outcome of the reassessment and the values.

Once this property is available the Township will fix up and dedicate as Pittenger Park, where there will be public access to the Pequest River.
