Mr. Brady addressed the Model Electric Vehicle Charging Station Ordinance Mr. Brady stated he will just incorporate this ordinance into any resolutions that apply to residential projects of 5 units of more and commercial site plans that having parking associated with it. He does not feel we can retroactively impose new requirements on a preliminary site plan at final. Mr. Holzhauer believes if a preliminary site plan comes in for a modification then this could be imposed at that time.
- 4. Kim addressed the incomplete application from Pub 517 and explained that after a number of emails to Melissa Johansson there still have not been additional documents submitted.
