• Memo from Pat Fischer, Zoning Official, regarding YMCA sponsored mobile farmer's market. Mrs. Peralta spoke with Health Department. There has been opposition from the other towns. Mrs. Fischer will continue to look into the zoning issues.

MATTERS FROM THE GOVERNING BODY: Mr. Bilik met with Mr. Donald Cichocki regarding the Quonset hut to house his aircraft at Trinca Airport. The hut is a temporary structure. The Committee discussed getting approval from the Construction Official. Mr. Cichocki mentioned there may be other requests to use Trinca Airport, which the Committee acknowledged and will review on a case by case basis. The Committee suggested a month to month lease.

Mr. Bilik requested an Executive Session to discuss possible contracts for emergency services. Mayor Conkling asked to hold discussion to the Executive Session portion of the meeting.

Mr. Kurzeja gave an update with information he obtained from CIT-e-net, a company popular with government websites. Phase I would be a new website with different functionality than the current website and can be expandable in the future. Phase II would include data relational databases. It would include secure email addresses. Mr. Stein explained that emails and texts are government records and subject to OPRA. Mr. Stein will provide more information for the next meeting regarding emails and OPRA.

Mayor Conkling and Mr. Jim Powderley updated the Committee on the recent OEM Meeting. Ways to notify residents in an emergency was discussed. Green Hills School will be used as a warming station and showers. Green Township will have a drill with Frelinghuysen. Mr. Nittolo, Principal of Green Hills School, would like to have a live drill in April or May, evacuate the students and bus to the Fire House and Municipal Building. Under the state program, Mr. Powderley has requested 8 small generators. Mrs. Peralta would like to include in the next issue of the Green Grapevine information on the Community Emergency Response Team (CERT) to see if there is interest from the community. Although Mr. Powderley is qualified to do the CERT team training, he suggested the residents be trained through the Sherriff's Department with follow-up training provided by him. An application for the CERT team will be available for residents to complete. The Committee agreed to opening this opportunity to ages 18 and up.

MATTERS FROM THE TOWNSHIP CLERK/ADMINISTRATOR: Mrs. Peralta noted the following:
