Mr. Ian Weisenthal, 6 Fox Hollow Way, has an issue with the cable company, Service Electric. He explained that he tried to get Optimum at his home and was told there is "no competition clause with Service Electric". He has contacted the Board of Public Utilities (BPU) and the Federal Communications Commission (FCC) both are not familiar with that term. Mayor Conkling stated that he understands Congressman Gottheimer is working with Service Electric to get better service. Mr. Zschack will look into the contract.

MATTERS FROM THE MUNICIPAL DEPARTMENT HEAD: Mr. Perigo stated several roads received power back this evening and roads were reopened. A couple roads are still out of power.

Mr. Zschack requested direction from the Committee on how the Township will handle the clean-up of brush debris from the recent storm. A discussion ensued concerning the responsibility of brush removal. It is the Committee's opinion that it is the responsibility of the property owner to clean up any storm damage. The Township will remove debris that fell in the Township's right of way.

MATTERS FROM THE GOVERNING BODY: Mrs. Raffay questioned who is responsible for paying the State Police that was stationed at Green Hills School this morning. Mr. Zschack answered the school would be responsible for paying for the State Police.

Mrs. Phillips asked when the garbage bid opening is scheduled for. Mrs. Phillips asked why the solid waste bid specs were not noted on the Township's website. Mrs. DeClesis stated that the QPA recommended not having the bid specs available on the website due to the inability to track companies that download the specs in the event of a change in the specs. There would be no way to track for proper notification on any changes. Mrs. Phillips requested in the future that we indicate information on the website on whom to contact for bid specs. Mrs. Phillips is concerned that the employees are up to date and trained on cyber security. Mr. Zschack mentioned that Statewide Insurance will be doing cyber training program for all municipalities.

Mayor Conkling complimented the road department on clearing township roads.

### MATTERS FROM THE TOWNSHIP CLERK: Mr. Zschack noted the following matters:

<u>DPW Communication System</u> - The current communication system that is in use by the DPW is in need of replacement. The existing system is low band and the replacement high band system could cost upwards of \$30,000. We would like to look into the possibility of replacing the low band with a cell phone system. With the uncertainty of the current system, employees are often utilizing personal cell phones to communicate. The purchase of smart devices will also be

warranted with the launch of a GIS system in 2020. We would like to research this type of system if the Township Committee has no objection. The Committee authorized looking into this system.

<u>DPW Water Purification System</u> - The test results of the water quality at the DPW garage has indicated a very high amount of salt in the water. The type of ionized system needed to remove the high levels of salt will cost approximately \$14,000 plus yearly maintenance. We were hoping to budget for this next year but the current storm demonstrated the need to expedite this purchase. There were five DPW employees at work from 9:00 a.m. Sunday morning until 4:30 p.m. Tuesday without the ability to shower never mind the abuse this water has on the plumbing fixtures. We will propose funding for this purchase at the December 16, 2019, meeting.

<u>Recreation Committee</u> - The Annual Tree Lighting scheduled for this Saturday, December 7, 2019, has been rescheduled to Saturday, December 14 at 4:30 p.m. in EverGreen Park. The Gingerbread House Decorating Event scheduled for tonight has been postponed to Monday, December 30, 2019, at 6:00 p.m. at the Green Township Fire House.

Hunts Pond Road - At previous meetings Mrs. Marge Vivian, 12 Hunts Pond Road, stated that she has called the State Police many times concerning speeding on Hunts Pond Road. The Township Engineer visited the site to see if speed humps or speed bumps could be installed to slow drivers down. Mr. Stoner cannot recommend speed bumps or humps due to sight distance restraints. The Township could consider installing additional signage along the roadway to warn drivers of the upcoming horizontal curves (W1-4R) or give them additional warning that pedestrians may be along the roadway (W11-2). The purpose of these signs would warn the drivers and get them to slow their speeds. There are other traffic calming devices that could also be considered (such as rumble strips and flashing warning signs), however, not sure that the level of concern at this location warrants such additional devices. Mr. Zschack did speak with the Sheriff's Department in person and spoke with Mrs. Vivian in person as well. Mrs. Vivian called and informed Mrs. DeClesis that one of the frequent speeders was caught by the Police.

Vacation - Mr. Zschack informed the Committee that he will be on vacation December 8-11, 2019.

<u>Recent Snowstorm/Power Outage</u> - Mr. Zschack stated that he noticed very good communications between our DPW and OEM throughout the recent snowstorm and power outage.

The Committee thanked and commended our OEM, CERT and emergency services on all their efforts during the recent storm and power outage.

Mr. Qarmout commented that it would be great to see pictures of the community working together in emergency events.

Mayor Conkling recommends an additional stipend for the OEM.

### RESOLUTION CALLING FOR STUDY COMMISSION TO REVIEW THE OPEN PUBLIC RECORDS ACT

WHEREAS, the Township of Green strongly believes in and supports open transparent government, and that citizens and residents have the right to be informed about the workings of government in order to best participate in a democracy; and

WHEREAS, on January 8, 2002 then Acting Governor DiFrancesco signed into law the Open Public Records Act (OPRA) which mandates that government records shall be available, with limited exceptions, for public access and simplifying the procedures for requesting such specific records; and

WHEREAS, the intent of the law was to provide the public with easy access to government records with an uncomplicated process for obtaining the records and eliminating bureaucratic red tape; and

WHEREAS, over the course of 18 years OPRA has been a positive light, but it has also been fraught with abuse and misuse, and has become an unanticipated financial cost to the taxpayers of New Jersey; and

WHEREAS, the Township of Green has labored under a well-intended law that has spiraled out of control, due to the volume and nature of requests, the cost to taxpayers in responding to the requests, and the potential liability in having to pay disproportionate prevailing party attorney's fees should the requests turn into litigated matters, as well as the liability in determining which documents shall be released, with or without redaction, while attempting to maintain individual privacy; and

WHEREAS, it is not only the volume of OPRA requests that challenge our resources, but it is also the cost associated with reviewing, retrieving, and processing the OPRA request(s) by public entity personnel and counsel and possibly defending our action(s) before the Government Records Council or in Superior Court; and

**WHEREAS**, the Township of Green received and responded to 110 OPRA requests in 2017, 100 OPRA requests in 2018, and to date has received and responded to 109 OPRA requests as of November 1, 2019; and

**WHEREAS**, the Township of Green municipal staff has spent approximately 100 hours responding to OPRA requests received in 2019 to date, and a yearly average of approximately 100 hours since 2017; and

WHEREAS, due to the often conflicting case law and Government Record Council decisions, as well as the unique characteristics of OPRA request, the Township of Green must often times rely on the municipal attorney to review certain OPRA requests, resulting in additional

attorney hours, including approximately 20 hours in 2017, 28 hours ins 2018, and 17 hours for the fist nine months of 2019 in response to OPRA requests; and

WHEREAS, with limited exceptions OPRA has not been amended to address the clear and apparent advancement in technology that has changed the way government records are created, stored, and/or transmitted; the various interpretive decisions; privacy concerns; abuse for commercial gain; and/or the ever-increasing cost to taxpayers; and

**WHEREAS**, as the current law approaches its twentieth (20<sup>th</sup>) anniversary it has outgrown its original intended use and has become ripe for comprehensive review and reform;

**NOW, THEREFORE BE IT RESOLVED** that the governing body of the Township of Green appeals to the legislature to form a Commission comprised of Mayors, Municipal Clerks, Municipal Managers, Attorneys, Police Chiefs, open government advocates, privacy experts, members of the media, citizens and other appropriate stakeholders, to review and examine the effects of OPRA on local government and the needs to be fulfilled by the law, and use the Commission's findings to perform a comprehensive reform of OPRA; and

BE IT FURTHER RESOLVED, that copies of this resolution be forwarded to Senator Steven V. Oroho, Assemblyman Parker Space, and Assemblyman Harold J. Wirths, Assembly Speaker Craig Coughlin, Senate President Stephen Sweeney, Senator Weinberg, Executive Director of the Government Records Council, the Governor of the State of New Jersey, the Municipal Clerks Association of New Jersey and New Jersey State League of Municipalities.

### **ORDINANCE NO. 2019-18**

### TOWNSHIP OF GREEN, COUNTY OF SUSSEX, STATE OF NJ

### AN ORDINANCE REVISING CHAPTER II, ADMINISTRATION, ARTICLE VI, DEPARTMENT OF PUBLIC WORKS, OF THE CODE OF THE TOWNSHIP OF GREEN

**WHEREAS**, the Green Township Committee has reviewed the current Township Code regarding the Department of Works and revisions are necessary.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Council of the Township of Green, Sussex County, New Jersey, that Chapter II, Administration, Article VI, Department of Public Works shall be revised as follows:

### **SECTION 1.**

Section 2-16.2 "Supervisor of Public Works" shall be deleted in its entirety and replaced as follows:

### 2-16.2 Department of Public Works Department Head

The Township Committee shall appoint the Department of Public Works Department Head, who shall report to the Township Clerk concerning matters of operation, personnel, planning, citizen inquiries, complaints or requests for assistance and such other matters pertaining to the Department which will enable the Clerk to exercise his/her responsibilities to the Committee. The Department Head shall also have authority to manage and allocate the Public Works Department personnel, subject to the review of the Township Committee.

### **SECTION 2.**

Section 2-16.3 "Appointment of Road Supervisor and Personnel" shall be deleted in its entirety.

### **SECTION 3-SEVERABILITY**

If any provision of this Ordinance or the application of this Ordinance to any person or circumstances is held invalid, the remainder of this Ordinance shall not be affected and shall remain in full force and effect.

### **SECTION 4 - REPEALER**

All ordinances or parts of ordinances or resolutions that are inconsistent or in opposition to the provisions of this Ordinance are hereby repealed in their entirety.

### **SECTION 5 - EFFECTIVE DATE**

This Ordinance shall take effect immediately upon adoption and publication in accordance with law.
