MATTERS FROM THE TOWNSHIP CLERK: The Township Clerk noted the following matters: Statewide Insurance Fund Award - On February 9, 2023, Green Township received the 2022 Loss Control Award for overall positive results for Workman's Compensation and all lines coverage. Kudos goes out to all employees with an extra nod to the Superintendent of Public Works and the DPW team.

**Social Media** - The Township has now added Instagram to the social media footprint of Green Township. Township posts will include the Website, Facebook, Twitter, Instagram and RAVE.

**Environmental Grant** - With the final upload of a resolution today, the environmental grant requesting \$2,000 for a pollination garden is complete.

**Tier B to Tier A Webinar** - Last week the Township Clerk/Administrator attended a webinar concerning the reassignment from Tier B to Tier A. There was an absence of new information but good questions were submitted. The Township Engineer is scheduled to meet next Tuesday with the Superintendent of Public Works and myself to discuss how the new DPW program will aid in data collection and storage of infrastructure.

Parking at Former Airport Property - There are cars parking and blocking the outside gate to the former airport. "No Parking" signs will be installed, but it should be considered to allow trailhead parking on the entrance road.

**5k Run** - The Newton Braves Cheer Team has requested the use of walking track, pavilion and County Connector Trail for a 5K color run on May 21, 2023. The Park Run organization that uses the park will adjust their event for the day.

A discussion ensued concerning the responsibility of clean up after the 5K color race particularly the bathrooms and pavilion. More information will be obtained from the organization regarding clean up and permits for food handling from the food truck vendors for further discussion.

MATTERS FROM THE GOVERNING BODY: Mr. Rose stated there may be grant money available for the change in tiers.

Mayor Phillips referred to the article in the New Jersey Herald regarding the Town of Newton and their five-year plan for reassessment. Their Tax Assessor justified the reasoning behind the five-year plan referring to the change in the equalization rate for 2022 to 2023. Mayor Phillips would like to hear from our Tax Assessor as to why we are not trying to do something sooner and to better understand the change in the equalization rates.

MATTERS FROM THE SUPERINTENDENT OF PUBLIC WORKS: The Superintendent of Public Works provided the following report read by the Township Clerk/Administrator:

**Tree Removal** - Tree King arrived Wednesday with two crews to finish the 2022 trees. They finished the trees at the lake, on Hillside and Dogwood. Thursday, they finished Hunts School Road trees.

Truck Mishap - Truck #6 sustained damage while dumping off material at the DPW complex. Report and claim filed. Operator was made aware of the proper way to dump off Truck #6. Adjuster came out and

reported back to the insurance company. Henderson Products will be at the DPW shop by weeks end to look over truck #6. The truck is out of service until repaired, spare chipping truck will be used if needed.

**iWorQ Software Update** - Currently, the Superintendent of Public Works, is finishing up the initial training for the new software to track all aspects of DPW and the new stormwater regulations. He will be working with the Township Clerk/Administrator since he was not here for the training sessions.

Municipal Building - With the absence of the Municipal Building Maintenance employee, the DPW has taken over most of their duties.

**Sign Board** - the orange tow behind sign trailer relocated to lower side of Whitehall Road for speed reminder. In addition to the sign board this year, we will add a radar attachment to the board. This will enable us to show speed of oncoming cars and upload to a report of speeds in the area on the current GPS system the sign board comes with.

**Street Signage** - new street signs have gone up on various roads. The DPW also took advantage of the summer like weather and got the chance to clean street signs and park signs.

**Speed Limit Sign** - The "DFB Sign" is the 12" Driver Feedback Value Sign w/ 60W Solar speed limit sign. The sign was placed on Green Farms Road by the rear entrance of GHS and had great reviews by the public in the area. The sign will be relocated over on Scenic Drive at the lake in hopes of reminding drivers of the speed limit and to slow down.

Gates - the informational signage for the gates came in and are up at the EverGreen Park and DPW garage.

**Sweeping** - the sweeper has been out on every road and parking lot in town at least one-time, other places multiple times.

Over the Rail Mowers - over the rail mowers will start trimming back the brush on the County Connector Trail this week.

**Guard Rail Installation** - repurpose guardrail was used down at the Tranquility Post Office to block access to the County Connector Trail from the parking lot. There have been reports of vehicles and ATV 's entering off the parking lot onto the trail.

Deputy Mayor Raffay asked if the DPW has removed the "No Dogs Permitted" signs at EverGreen Park. The Township Clerk/Administrator will look into.

# AN ORDINANCE REVISING SECTION 2-40.8 OF THE GREEN TOWNSHIP CODE TO DECREASE THE ANNUAL OPEN SPACE, RECREATION, FARMLAND PRESERVATION AND HISTORIC PRESERVATION TRUST FUND TAX LEVY TO \$0.01 PER \$100 OF ASSESSED VALUATION, BEGINNING IN YEAR 2023

WHEREAS, Green Township municipal voters, on the general election ballot on November 4, 1997, voted in favor of establishing a municipal Open Space, Recreation, Farmland Preservation, and Historic Preservation Trust Fund for the acquisition and preservation of municipal open space, recreation, farmland preservation, and historic preservation at a yearly rate not to exceed \$0.03 per \$100 of assessed valuation; and

**WHEREAS**, Green Township Code, Section 2-40,et seq., established the Open Space Committee and set forth funding for the municipal Open Space, Recreation, Farmland Preservation, and Historic Preservation Trust Fund; and

WHEREAS, Green Township Code, Section 2-40.8 established funding through the dedication to the fund in the amount of \$0.03 per \$100 of assessed valuation of each annual tax levy commencing with the year 1998; and

WHEREAS, N.J.S.A. 40:12-15.7(b) allows for the governing body of the municipality to annually raise by taxation a sum not to exceed the amount or rate set forth in the proposition approved by the voters, and the governing body may determine the appropriate amount or rate to be allocated to each purpose after conducting at least one public hearing thereon; and

**WHEREAS**, the Green Township Committee hereby desires to decrease the current funding amount for the annual tax levy to \$0.01 per \$100 of assessed valuation of each annual tax levy, commencing with the year 2023.

**NOW THEREFORE**, Green Township Code Section 2-40.8 shall be revised to decrease the annual tax levy to \$0.01, as follows:

#### **SECTION 1**

Section 2-40.8 shall be deleted in its entirety and replaced with the following:

§ 2-40.8 Funding of the Reserve for Open Space Acquisition.

#### ORDINANCE NO. 2023-03 TOWNSHIP OF GREEN COUNTY OF SUSSEX, STATE OF NEW JERSEY

The Reserve for Open Space Acquisition shall be funded through the dedication to the fund of an amount of \$0.01 per \$100 of assessed valuation of each annual tax levy commencing with the year 1998. The reserve shall also be permitted to accept donations and testamentary bequests. The funds accumulated within the reserve may be utilized for the acquisition of land or development rights in land or as a down payment for the issuance of bonds for the same purpose at the discretion of the Township Committee or for the payment of debt service or indebtedness issued or incurred by the Township for any purpose contemplated by this section. Any and all interest accruing shall remain in the reserve and may be utilized for the above-described purposes.

#### **SECTION 2 - SEVERABILITY**

If any provision of this Ordinance or the application of this Ordinance to any person or circumstances is held invalid, the remainder of this Ordinance shall not be affected and shall remain in full force and effect.

#### **SECTION 3 - REPEALER**

All ordinances or parts of ordinances or resolutions that are inconsistent or in opposition to the provisions of this Ordinance are hereby repealed in their entirety.

#### **SECTION 4: EFFECTIVE DATE**

This Ordinance shall take effect immediately upon adoption and publication in accordance with law.
