MATTERS FROM THE TOWNSHIP CLERK: Mr. Zschack noted the following matters:

Stormwater Control Ordinance - The Township Attorney has informed the Township that amendments to the Green Stormwater Control Ordinance are warranted. Green Township needs to revise its stormwater ordinance, Section 30-17.1A of the Township Code, by March 2, 2021, per amendments to the Stormwater Management rules at N.J.A.C. 7:8. It does not appear that the entire ordinance will need to be replaced and we are awaiting a review by the Township Engineer.

Sale of Firetruck - The City of Perth Amboy is in need of an old pumper truck and has contacted Mike Rose for the consideration of a direct sale of the 1994 Lance Pumper. The QPA has informed us that an interlocal sale is allowable from municipality to municipality without further bidding. Perth Amboy is looking to purchase an engine by the end of January with a cost between \$10-\$15,000. Representatives from Perth Amboy are scheduled to inspect the vehicle this week. The Township Attorney has drafted a resolution that will be presented to the Township Committee at the January 20, 2021, meeting. The sale price will need to be determined once their inspection is complete.

MATTERS FROM THE GOVERNING BODY:

Mayor Phillips thanked the Committee for the reappointment as Mayor. Mayor Phillips discussed the increased number of positive COVID-19 cases in Green Township. The Committee discussed the continuation of in person meetings or moving to remote and the possibility of closing the municipal building to the public. After discussion, it is the consensus of the Committee at this time the municipal building will be open with all necessary precautions in place and to continue with in person meetings. The Committee will continue to evaluate the situation and make changes if necessary.

Mr. Conkling commented that engaging in social media has been a huge plus this year in getting the information out to our residents. Mr. Conkling commented that he noticed Wesley Field is now closed. Recently Wesley Field has been used as a dog park and as a site for dumping wood chips. A discussion ensued on where residents can walk with their dogs which is the County Connector Trail or the EverGreen Trail. It is suggested to include better signage that dogs must be leashed on the trails and stress that parking is permitted in the EverGreen Trail parking lot.

Mr. Conkling asked about the Forest Road drainage. Mr. Zschack stated that the Township Engineer is just back from vacation. Mr. Conkling feels that the issue should have been done correctly with no further costs to the Township.

Mrs. Raffay discussed a complaint that was received concerning an outdoor wood burning furnace. The issue is that there is a significant odor and excessive visible smoke coming from the outdoor furnace. Mrs. Raffay thanked Mayor Phillips for reaching out to the resident. The matter is being looked into and will be addressed.

Mr. Qarmout wished everyone Happy New Year and looks forward to continuing working together in 2021. Mr. Qarmout is proud of our leadership and noted the importance of concern for the residents of Green Township.

Mr. Conkling would like to see a written report provided by the Municipal Department Head and the Superintendent of Public Works for the Township Committee Meetings.

WHEREAS, the Claimant Certification CANNOT be waived for the following:

- Deposits in advance of work performed
- An Individual (e.g. sole proprietors)

WHEREAS, The Chief Financial Officer has communicated internal accounting controls as follows and has determined same to be sufficient to avoid errors and fraud in the processing of claims for payment.

- 1. No goods or services will be procured without a valid Purchase Order containing signature of the Township Clerk and Chief financial Officer.
- 2. Except for contract items approved by resolution of the Governing Body, all procurement transactions must originate by way of a requisition. Requisitions will not be processed without a written or digital signature of the Department Head.
- 3. Requisitions that exceed the bid threshold (currently \$44,000) will be required to go through the bid process as stated in the Local Public Contracts Law (N.J.S.A. 40A: 11-3 and N.J.S.A. 40A:11-4) and will require claimant certification.
