#### MATTERS FROM THE TOWNSHIP CLERK/ADMINISTRATOR:

Mr. Zschack offered the following report:

- The Municipal Building has experienced intermittent internet service. To correct this problem, we are switching to a cable based service with PenTeleData.
- Clean Communities cleanup is scheduled for April 22<sup>nd</sup>. As usual local organizations, will be involved in the cleanup of garbage along Township roads and properties. Additionally, the Road Department collects tires, car batteries and metal. This year the collection of E-Waste will also be added.
- Student Government Day is scheduled for May 1<sup>st</sup>. Students arrive in the morning for a short program then take a guided tour of the Township. Lunch is provided and all students return at night to join the Township Committee for the regular meeting. All members of the Township Committee are encouraged to participate in the daytime program.
- The Township submitted an application for a grant to receive tree seedlings. These trees will not be available to distribute on Clean Communities Day but will be dispensed on Spring Yard Sale Day which is scheduled for May 6<sup>th</sup>.

- The additional survey at the intersection of CR 517 and Scenic Drive is complete and was forwarded to the County. This survey will determine the number of trees that will be removed to expand the sight distance to increase safety. Once this area is marked out we encourage all Township Committee members to visit the site.

- The Natural Gas Survey, from Elizabethtown Gas, should be received by all Township residents around March 15<sup>th</sup>.
