CORRESPONDENCE: Mrs. Peralta noted the following:

- The State of New Jersey Department of Transportation has opened the application process for grants off road trails for pedestrians, bicycles, and non-motorized forms of transportation. The Open Space Committee is pursuing the rails to trails pathway. Mrs. Peralta suggested consulting with the Land Conservancy as well as Suburban Consulting Engineers. The Committee agreed to move forward with the application process.
- Letter from a resident on Hibler Road regarding the loose stone on Hibler Road. Mr. Perigo explained that the sweeper had just repaired allowing the DPW to begin the clean-up process. The Road Department is currently down to just two employees. Another factor is the temperature needed to cool down prior to sweeping the roads.
- Request from Andover Borough to the Mayors of Andover Township and Green Township to regarding the annexation by the Borough of Andover of two lots. Mr. Stein that there is a statutory process that allows municipalities to change the boundaries to move properties from one municipality to another. Green's small portion would become Andover Borough's jurisdiction. Mrs. Holenstein, Tax Assessor, further explained that the land is very small and farmland assessed. Each year Andover Borough files their farmland assessment with Green Township. Mr. Stein stated there is a statutory process that allows municipalities to adjoin. Mr. Stein will look into an agreement not an annexation and advise the Committee at next meeting.

MATTERS FROM THE GOVERNING BODY: Mr. Conkling asked for an update on Scenic Road and County Route 517. Mr. Stein has left a message with Mr. Williams and will follow-up. Mr. Conkling suggested a meeting with the new members would be beneficial. Mr. Conkling commented that the new walls at the old firehouse look great. Mayor Phillips asked if longer leaders can be installed to move the water away from the building. Mr. Perigo has been looking into the leaders.

Mayor Phillips received an application for membership on the Open Space Committee. Mayor Phillips has previously met the applicant. Mayor Phillips noted that since there are currently no open positions, Mrs. DeClesis has offered to step down as an alternate on the Open Space Committee. Mrs. DeClesis is also the secretary of the Open Space Committee and was appointed an alternate on the Committee for quorum purposes. After a brief discussion, the Committee approved the appointment of Mr. Cerame to the Open Space Advisory Committee.

Mayor Phillips commented that she attended the Fun Fly event held at Trinca Airport and thought it was well attended. Mr. Perigo further commented that the event went smoothly.

Mr. Qarmout also commented that the new walls at the old firehouse looks great.

Mr. Conkling inquired about 8 Michael Court. Mr. Stein explained that he has written an extensive letter to the attornies foreclosing on the property explaining that the information they provided is completely false. They have no record of this property. Mr. Stein will follow-up but stated that it is premature to issue summons at this time.

MATTERS FROM THE TOWNSHIP CLERK/ADMINISTRATOR:

- Update on large public gatherings Mr. Stein stated that the anti-Woodstock ordinances that were adopted in the 1970s have been repealed.
- Mrs. Peralta stated that generally one or more professionals are RFPed each year as per best practices. In the rotation cycle, it would be the Township Planner's opportunity this year. Mrs. Peralta noted that the Township Engineer, Mr. John Miller is retiring at the end of this year. Mr. Miller is named as Principal Engineer as per the contract. The Township can retain the engineering firm if preferred or decide to RFP for Township Engineer as well as the Township Planner. After a brief discussion, the Committee agreed to RFP for the Township Engineer for this year.

- The ultralight application for use of Trinca Airport by ultralight aircraft users will go into effect after the adoption of an Ordinance.

- 5. We understand that we are required to provide the Division of Pensions and Benefits complete copies of all contracts, ordinances, and resolutions that detail post-retirement medical payment obligations we undertake. We also recognize that we may be required to provide the Division with information needed to carry out the terms of this Resolution.
