Outstanding Older American

The 2018 Outstanding Older American has been chosen but unfortunately is unable to attend Green Township Day. We are working on an alternate date to present the award. Please remember the recipient is not aware of the award.

Green Township Day

We are putting the final touches on the plans for Green Township Day which takes place this Saturday from Noon until 4:00 p.m. Included in the opening ceremonies this year will be the official opening of the new County Connector Rail to Trail that abuts EverGreen Park. We are working with the Township's Risk Manager, Wayne Dietz to ensure a safe and entertaining hayride along the new trail. Hayrides will run from 12:30 p.m. to 2:00 p.m.

Lawn Maintenance Services

Without any advanced notice Total Lawn Care and Landscape Services, the Township's lawn maintenance company, has closed its doors. As of now the DPW will maintain the grass cutting. There is about \$11,000.00 remaining that was not paid out that could also be used to bring in an outside contractor.

We will be scheduling a Personnel Sub-Committee meeting soon to discuss the professional services for 2019.

As determined last year we will be reviewing the current policy concerning the opening and closing of the gates at various parks. There was discussion last year concerning the park schedule. The Committee briefly discussed keeping the gates open during the winter months. Mr. Zschack will check with the Risk Manager about use of the park when snow covered.

MATTERS FROM THE TOWNSHIP ATTORNEY: Mr. Bolcato noted no matters for discussion.

MATTERS FROM THE MUNICIPAL DEPARTMENT HEAD: Mr. Perigo commented that dogs are being walked in Papa Park and generally the garbage is almost full of baggies of waste. The municipal parking lot at the Fire House and Greendell Post Office has been milled and paved. The Committee complimented the work done.
