#### **Employee Evaluations**

As-per the Employee Handbook we have started the process of performance reviews for all employees. Once the self-assessment reviews are filled out by the employee, the administration will also fill out a review and sit with each employee to discuss the results. All results will then be submitted to the Personnel Committee for review.

#### **Fulton Leasing Company**

Mr. Perigo recently attended a seminar concerning the leasing of municipal vehicles. The Fulton Bank, Route 517 in Hackettstown has a leasing company that leases to municipalities in New Jersey. Fulton has provided a list of references that we are checking into before we consider this scenario. More information will be provided as we look into this type of agreement.

#### Forest Road Flooding

The Township received an email from the resident at 81 Forest Road concerning the flooding of his property. In August of 2018 the Township installed a seepage pit in the roadway in front of this property. This fix was to remove standing water in the roadway and try to prevent runoff into this property. It was known at the time of install that this solution would not solve all of the issues but take care of most rain events without incident. Does the Committee wish to have the engineer submit a proposal to perform a drainage study to determine a permanent solution to the roadway flooding? The solution does not appear to be simple, therefore could be very costly.

Mayor Conkling would like to meet with the Township Engineer and Municipal Department Head at the site to see what can be done.
