#### MATTERS FROM THE TOWNSHIP CLERK: The Township Clerk noted the following matters:

**Daniels Law** - Minutes and agendas have been temporarily removed from the website for all Boards and Committees. This was done out of an abundance of caution until a method of managing this law is determined. Moving forward new minutes will be posted with all addresses removed. The regulations will be reviewed to determine the best way to manage all aspects of this law. Addresses will not be requested at Township sponsored meetings to keep this vital information from all future minutes.

Interest Rate for Open Space Monies - The Open Space accounts are held in two separate accounts. Provident Bank has \$539,000 and receiving a .50% interest rate and \$1,316,000 in a NJ Cash Management Fund at 4.21%. The CFO has been working on receiving a higher interest rate from Provident bank and/or looking for alterative depositories.

**Tier B to Tier A** - Last week the Township Clerk and Superintendent of Public Works met with the Township Engineer to review the requirements for the change to Tier A. There is not an immediate cost impact due to the actions that the DPW already incorporates. The time that is warranted to complete the 2023 tasks is a bit daunting. Assistance will be needed to research and produce an Operations and Maintenance Manual. Recommendations will be submitted once all potential solutions of in-house or hire a professional have been reviewed.

Natural Gas to Green Hills School - Elizabethtown Gas has finalized their design for the main and service to serve the school. This main is proposed to run from Airport Road to the school via Pequest and Mackerley Roads. We are awaiting the receipt of the plans to determine the impact on the newly paved roads.

**5k Run** - The Newton Braves Cheer Team has withdrawn their Use of Facilities application to hold a 5K color run event on May 21, 2023.

Sussex County Division of Health - The County Health Department has requested a meeting to review programs offered, staffing within their department, and a question-and-answer session. The meeting is set for March 28, 2023, at 12:00 p.m. Please submit any questions and/or concerns before said meeting date.

**Bicentennial Committee** - The Bicentennial Committee has discussed the creation of a charitable fund to collect donations for the Bicentennial events. We were asked to review the viability of such an account. A charitable fund may be created by ordinance, per NJSA 54:4-66.7 and NJAC 5:30-18.2. Tom Ferry's recommendation is a dedication by Rider for that specific purpose, Donations – Acceptance of Bequests and Gifts (NJS 40A:5-29), must indicate specific use of funds.

MATTERS FROM THE GOVERNING BODY: Qarmout commented that Green Township's cost for propane is much higher than what he is paying. The Township Clerk will review the invoices from the propane company.

Deputy Mayor Raffay asked if anyone received a Township email that indicated "due". Mayor Phillips stated there was a spam email received that should not be opened.

Deputy Mayor Raffay commented that many people are using the park to walk their dogs. The Township Clerk added that no complaints have been received to date.

MATTERS FROM THE TOWNSHIP ATTORNEY: The Township Attorney had no matters for discussion.

MATTERS FROM THE SUPERINTENDENT OF PUBLIC WORKS: The Superintendent of Public Works provided the following report read by the Township Clerk/Administrator:

- Continuing to take advantage of the nice weather, working on projects in preparation of springtime.
- Replaced catch basin lids to make them both safer and up the code with the storm water regulations
- Continuously doing small jobs at Town Hall and both Post Offices buildings
- Starting to work on the baseball and softball fields for the season
- Patching holes various roads with winter mix so that they hold until hot mix is being made
- Relocated speed enforcement /reminder solar bored over to Scenic Road. Tow behind signboard relocated to lower Whitehall Road for speed reminder
- Cleaning up storm debris from the recent windstorms

DeYoung inquired about the interviews for the DPW position. The Township Clerk responded that the resumes are being reviewed for the Personnel Subcommittee to interview.

#### ORDINANCE NO. 2023-03 TOWNSHIP OF GREEN COUNTY OF SUSSEX, STATE OF NEW JERSEY

# AN ORDINANCE REVISING SECTION 2-40.8 OF THE GREEN TOWNSHIP CODE TO DECREASE THE ANNUAL OPEN SPACE, RECREATION, FARMLAND PRESERVATION AND HISTORIC PRESERVATION TRUST FUND TAX LEVY TO \$0.01 PER \$100 OF ASSESSED VALUATION, BEGINNING IN YEAR 2023

WHEREAS, Green Township municipal voters, on the general election ballot on November 4, 1997, voted in favor of establishing a municipal Open Space, Recreation, Farmland Preservation, and Historic Preservation Trust Fund for the acquisition and preservation of municipal open space, recreation, farmland preservation, and historic preservation at a yearly rate not to exceed \$0.03 per \$100 of assessed valuation; and

**WHEREAS**, Green Township Code, Section 2-40, et seq., established the Open Space Committee and set forth funding for the municipal Open Space, Recreation, Farmland Preservation, and Historic Preservation Trust Fund; and

WHEREAS, Green Township Code, Section 2-40.8 established funding through the dedication to the fund in the amount of \$0.03 per \$100 of assessed valuation of each annual tax levy commencing with the year 1998; and

WHEREAS, N.J.S.A. 40:12-15.7(b) allows for the governing body of the municipality to annually raise by taxation a sum not to exceed the amount or rate set forth in the proposition approved by the voters, and the governing body may determine the appropriate amount or rate to be allocated to each purpose after conducting at least one public hearing thereon; and

**WHEREAS**, the Green Township Committee hereby desires to decrease the current funding amount for the annual tax levy to \$0.01 per \$100 of assessed valuation of each annual tax levy, commencing with the year 2023.

**NOW THEREFORE**, Green Township Code Section 2-40.8 shall be revised to decrease the annual tax levy to \$0.01, as follows:

#### **SECTION 1**

Section 2-40.8 shall be deleted in its entirety and replaced with the following:

§ 2-40.8 Funding of the Reserve for Open Space Acquisition.

#### ORDINANCE NO. 2023-03 TOWNSHIP OF GREEN COUNTY OF SUSSEX, STATE OF NEW JERSEY

The Reserve for Open Space Acquisition shall be funded through the dedication to the fund of an amount of \$0.01 per \$100 of assessed valuation of each annual tax levy commencing with the year 1998. The reserve shall also be permitted to accept donations and testamentary bequests. The funds accumulated within the reserve may be utilized for the acquisition of land or development rights in land or as a down payment for the issuance of bonds for the same purpose at the discretion of the Township Committee or for the payment of debt service or indebtedness issued or incurred by the Township for any purpose contemplated by this section. Any and all interest accruing shall remain in the reserve and may be utilized for the above-described purposes.

#### **SECTION 2 - SEVERABILITY**

If any provision of this Ordinance or the application of this Ordinance to any person or circumstances is held invalid, the remainder of this Ordinance shall not be affected and shall remain in full force and effect.

#### **SECTION 3 - REPEALER**

All ordinances or parts of ordinances or resolutions that are inconsistent or in opposition to the provisions of this Ordinance are hereby repealed in their entirety.

#### **SECTION 4: EFFECTIVE DATE**

This Ordinance shall take effect immediately upon adoption and publication in accordance with law.

CAPITAL ORDINANCE FOR IMPROVEMENTS TO CREEK ROAD, PHASES I & II IN BY THE TOWNSHIP OF GREEN IN THE COUNTY OF SUSSEX, NEW JERSEY, APPROPRIATING THE TOTAL OF \$620,000.00, OF WHICH \$98,000.00 IS FROM THE GENERAL CAPITAL-CAPITAL IMPROVEMENT FUND, \$80,505.00 GENERAL CAPITAL-RESERVE FOR IMPROVEMENTS TO ROADS, \$67,515.00 GENERAL CAPITAL FUND BALANCE, \$203,200.00 FROM NJDOT 2021 MUNICIPAL AID PROGRAM, AND \$170,780.00 FROM NJDOT 2022 MUNICIPAL AID PROGRAM

## BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF GREEN, IN THE COUNTY OF SUSSEX, NEW JERSEY, AS FOLLOWS:

Section 1. The improvements to Creek Road, Phases I and II are hereby authorized as general improvements to be made or acquired by the Township of Green, New Jersey. For the said improvements or purposes stated in said Section 2, there is hereby appropriated the total sum of \$620,000.00; with \$98,000.00 from monies available in the General Capital – Capital Improvement Fund, \$80,505.00 General Capital – Reserve for Improvements to Roads, \$67,515.00 General Capital Fund Balance of the Township, \$203,200.00 in funding being provided by the New Jersey Department of Transportation's (NJDOT), Fiscal Year 2021 Municipal Aid Program and \$170,780.00 in funding being provided by the New Jersey Department of Transportation's (NJDOT), Fiscal Year 2022 Municipal Aid Program

Section 2. The improvements hereby authorized and the purpose for which said appropriation is made are for the improvement of Creek Road, Phases I and II in the Township of Green.

Section 3. The capital budget or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith and the resolutions promulgated by the Local Finance Board showing all detail of the amended capital budget or temporary capital budget and capital program as approved by the Director, Division of Local Government Services are on file with the Township Clerk and are available for public inspection.

#### ORDINANCE NO. 2023-04 TOWNSHIP OF GREEN, COUNTY OF SUSSEX

- Section 4. The following additional matters are hereby determined, declared, recited and stated:
- (a) The said purposes described in Section 2 of the capital ordinance are capital expenses and are each a property or improvement which the Township may lawfully acquire or make as a general improvement, and no part of the cost thereof has been or shall be specifically assessed on property specially benefited thereby.
- (b) The average period of usefulness of said purposes within the limitations of said Local bond Law and taking into consideration the respective amounts of the said obligations authorized for the several purposes, according to the reasonable life thereof computed by this capital ordinance, is fifteen (15) years.

Section 5. This ordinance shall take effect after publication after final adoption, as provided by law.
