## Happy New Year!

### Dog License 2026

All dogs 7 months of age and older must be licensed and all licenses are to be renewed by January 31, 2026. IF LICENSES ARE NOT RENEWED ON TIME A LATE FEE OF \$5.00 PER DOG PER MONTH WILL BE IMPOSED AFTER FEBRUARY 10TH.

Per State Law, a license cannot be issued if the current rabies vaccination expires before November 1, 2026. If you do not renew the license, a court complaint/summons will be issued.

The Township of Green operates under the Township form of government. This is the oldest form of municipal government in New Jersey, having been first established by the Township Act of 1798. The township form of government is "government by committee" with the legislative and executive responsibilities of the municipality vested in the township committee as a whole. The Committee establishes policies for the administration of the various departments and appoints the Township Administrator who is responsible for carrying out those policies and overseeing the day to day operations of the township.

The Township Committee members are elected officials whose three year terms of office begin on January 1 following their election at the November General Election. At the reorganization meeting during the first week of January, the Township Committee elects one of their members to be the Mayor and another to be the Deputy Mayor.

## Zoning

### WHEN IS A ZONING PERMIT IS REQUIRED?

A zoning permit is required prior to the construction of new homes, additions, renovations, decks, sheds, swimming pools (above ground and in ground), accessory structures, fences, change of use, and any other structures or improvements which may be required in accordance with the municipal code. The property owner shall be asked to submit an Application for Zoning Permit to the Zoning Official so that he can review the project for compliance with the Zoning Ordinance. Application for Zoning Permit is available at the municipal office during regular business hours.



### WHAT ARE THE FEES TO APPLY FOR AN APPLICATION FOR ZONING PERMIT?

New Construction – Commercial \$150.00

New Construction – Residential \$100.00

Accessory Structure \$ 35.00

Alterations \$ 25.00

Nonconforming Use Certificate \$ 50.00

Resubmit of Denied Application \$ 15.00  
(within 1 year of original submission)

### WHAT IF YOUR PROJECT DOES NOT COMPLY WITH THE ZONING ORDINANCE?

If the property owner can not comply with the Zoning Ordinance for any reason, a variance must be obtained from the Land Use Board before the project can proceed. The Zoning Official is charged with the responsibility of enforcing the Zoning Ordinance, and may not waive the requirements. That power is granted by law to the Land Use Board. If the project does require a variance, the Land Use Board Secretary, Kim Mantz, will explain the application process to you.

## Construction Violations

### WHAT HAPPENS IF WORK IS DONE WITHOUT A PERMIT?

The State of New Jersey law, the Uniform Construction Code (UCC), makes it mandatory that when a Construction Official becomes aware that an owner or his/her agent fails to obtain a required permit prior to commencing construction, the Construction Official shall issue a Notice of Violation/ Order to Pay Penalty to the owner of the property and/or his/her agent. The penalty can be up to \$2,000 per subcode and an additional \$2,000 per week that the violations remain outstanding. The violation may lead to a summons to appear in municipal court to enforce the payment of the penalty.

### WHAT HAPPENS IF A VIOLATION IS ISSUED?

If a violation is issued you will need to obtain a permit by the deadline stated in the violation or you will begin to accrue additional fines, potentially at \$2000 per week. In some cases, you may need to apply for a Zoning Permit prior to the Construction Permit depending on the work that was done. The forms needed to apply for a Construction Permit are available in the Construction Office at Town Hall and the Zoning Permit Application is available on our website: [www.greentwp.com](http://www.greentwp.com) under the Zoning Tab.

**There have been a large number of violations in town lately resulting in severe penalties. If you are unsure if the work you are proposing to do in your home or yard needs a permit please contact the Construction Department at 908.852.9333 x12.**

## Fire Hydrants

Township Code 17-2.7.1

### Removal of Snow Around Fire Hydrants

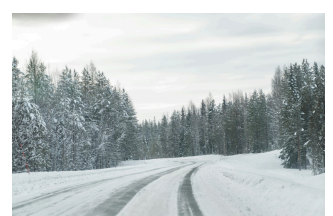
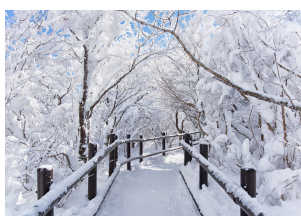
The owner, owners or lessees of any real property in the Township abutting any fire hydrant shall maintain the area within a five-foot radius of the perimeter of any such fire hydrant free of snow. The removal of snow shall be completed within 24 hours of daylight after the snow has formed or fallen or accumulated on or around any fire hydrant. On failure to perform the required clearance within the specified time frame, the Township, or any department thereof, may perform the clearance and bill the responsible party no more than \$75.

## Parking/Snow Plowing

There is **NO PARKING** on any road during snow storms, cars will be towed at owner's expense. There will be **NO** plowing, shoveling, or snow blowing of snow **INTO** or **ACROSS** the roads. Please make sure all sidewalks on your property are cleared of snow within 24 hours of storm.

## EverGreen Park Bathrooms

The bathrooms at EverGreen Park are closed for the season. This closure prevents the pipes from freezing and is necessary for the protection of the systems. A temporary, handicap accessible bathroom will be available throughout the winter.





## Traffic Stops in Green Township



Every year the municipal building receives numerous calls concerning speeding, erratic driving and unlawful parking in Green Township.

Last year Green Township entered into an interlocal agreement with the Andover Police Department to provide traffic enforcement services.

It is the opinion of the Green Township administration that this service helped reduce the number of complaints concerning roadway safety.

There was a total of 408 traffic stops resulting in 268 citations issued throughout the year.

The Green Township Committee is committed to improve the safety of the roadways by engaging in this agreement again in 2026.

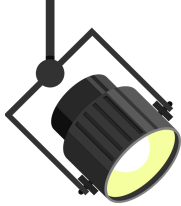

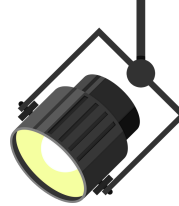

**DIABETES SELF MANAGEMENT PROGRAM-** Action Plans for Enhancing Wellness for adults of all ages and caregivers who are dealing with Type 2 diabetes. FREE Peer led, six-week (2 ½ hour sessions) self- management program that is goal-oriented and includes a FREE manual, "Living a Healthy Life with Chronic Conditions."

**CANCER: THRIVING AND SURVIVING** - Action Plans for Enhancing Wellness for adults of all ages of all ages and caregivers who are dealing with all forms of cancer. FREE Peer led, six-week (2½ hour sessions) self-management program that is goal-oriented and includes a FREE manual, "Living a Healthy Life with Chronic Conditions."

**STRESS-BUSTING PROGRAM FOR FAMILY CAREGIVERS** - An evidence-based program which provides support for caregivers of individuals with chronic conditions. Helps to improve the quality of life of caregivers and assist them with managing stress and being able to cope better in their lives. FREE peer led, 9 week program (90 minute sessions). Many new skills are introduced and information about the disease process, stress management techniques and more are provided.

**MOVE TODAY** - FREE, peer-led, 12 session (approx. 1 hour each) non-aerobic exercise program using resistance bands. This program is designed to improve flexibility, balance, stamina, muscle strength, posture, and body mechanics. Resistance bands and manual provided.
